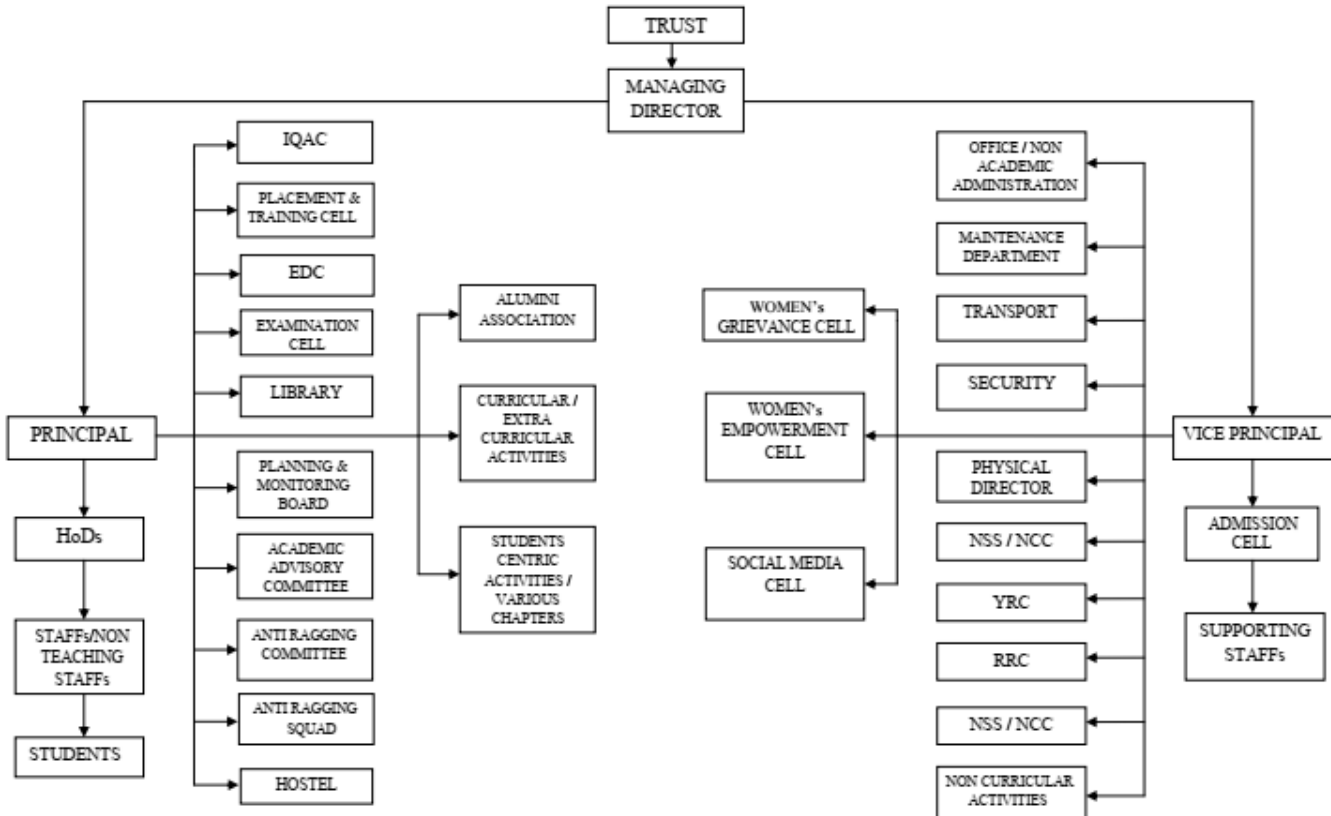
##### **Nature and Extent of involvement of Faculty and students in academic affairs / improvements**

This may include perceptions about the learning and teaching, the learning support facilities (such as, libraries, computing facilities), the learning environment, (lecture rooms, laboratories, social space and university buildings),, support facilities (refectories, student accommodation health facilities, student services) and external aspects of being a student (such as finance, transport infrastructure).

Student views are usually collected in form of 'Student' feedback. Sometimes there are specific attempts to obtain student views on how to improve specific aspects of provision or on their views about potential or intended future developments but this is less usual. It is not always clear how views collected from students fit into institutional quality improvement policies and processes. To be effective in quality improvement, data collected from surveys and peer reviews are transformed into information that is used within our institution to have effect change.

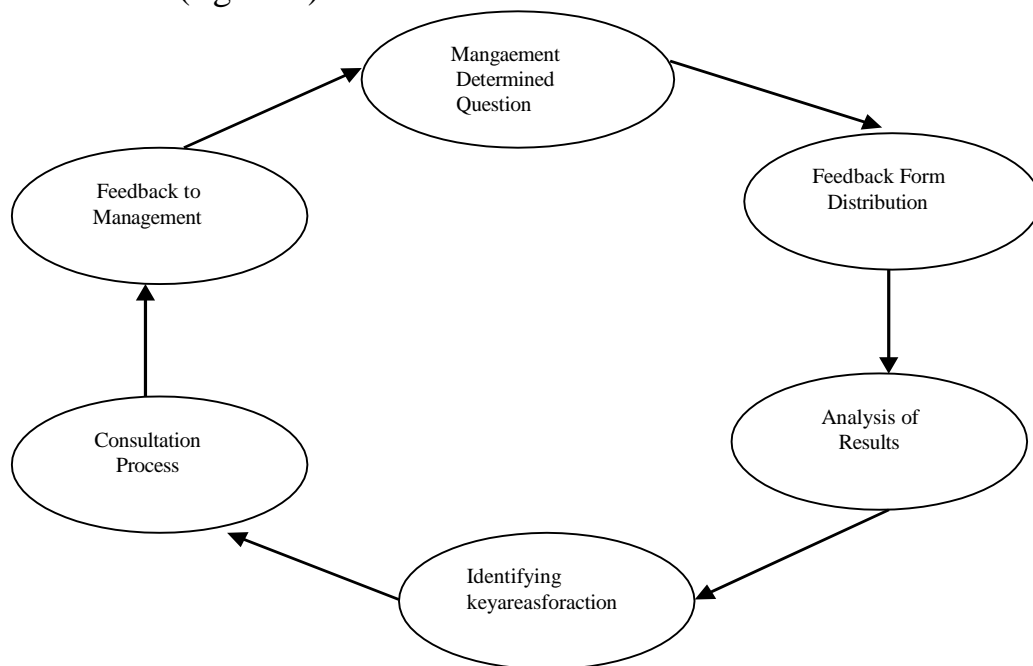


### Mechanism / Norms and Procedure for democratic /good Governance
